## Terms and Conditions

Lockwood Hunting Services (LHS) does not guarantee any of its hunts, although a 100% effort will be made to ensure that your hunt is successful. Weather conditions may greatly affect the outcome of your hunt. These conditions, you must realize, are beyond our control. Being physically fit and prepared with the proper gear will increase the odds of success on your hunt as well.

LHS guides have the experience and knowledge to help provide you with information and decisions on obtaining the size trophy that you desire, but you as the shooter are ultimately responsible for making the decision on the animal you shoot. *If an animal is injured it will be counted as your kill.*

*All bookings and deposits are non-refundable. A 50% deposit must be made to officially book any hunt. Final payments are due at least 10 days prior to the hunt date. If the final payment is not received at least 10 days prior to the hunt date the hunt is cancelled and deposit forfeit. We suggest that you purchase travel insurance before booking your hunt to protect you in the event of you not being able to attend your hunt. Deposits cannot be applied towards another hunter or hunt. All payments must be made payable to Lockwood Hunting Services. Your booked hunting dates must be consecutive for each hunt. A 4% fee will be applied to all credit card purchases. The advertised rate is the cash or check rate. A \$50 fee will be charged to the client for each returned check. LHS reserves the right to deny anyone service.*

If you are unable to make a hunt that you have booked, the deposit may be moved to a different hunt date or time frame at LHS discretion. No refunds and/or alternative hunt dates for early departure.

Gratuities are not included in our rates. It is customary to tip your guide and cook on the hunt. LHS does not handle the tips. If you decide to tip your guide(s) and cook please bring cash and individually tip each guide and cook that assisted you. A customary tip is a minimum of 10% of the price of your booked hunt.

Follow the guides rules at all times. Do not chamber any round or fire your weapon until the guide instructs you to do so. If you are behaving in a dangerous manner the hunt will be stopped immediately with no refund.

It is your responsibility to have your weapon sighted in before arrival. The guide may ask you to place a few rounds at a target to ensure your accuracy. It is also your responsibility to have all of your proper hunting gear including game bags and coolers to put your game and trophy cape into unless you have made prior arrangements with us to have it dropped off at our local butcher/taxidermist for you. It is your responsibility to take your game to the butcher and taxidermist. It is also your responsibility to have your transportation, meals and lodging taken care of in advance unless the fully outfitted hunt is booked.

Killing off game is prohibited. Coyotes are the only exception. If you kill any animal other than coyotes and/or the animal that we are hunting then the hunt will be stopped immediately with no refund. The killing of pregnant or wet sow pigs is not permitted. If a pregnant or wet sow is killed then a \$100 fee will be added to the hunt. If the sow has piglets inside her or if she is lactating then you will be charged the fee.

Initial (            )

Once the hunted animal is killed then your hunt is concluded. If you would like to continue hunting there is an additional day fee that starts from when field dressing and skinning is complete and ends 24 hours later. Hunting will resume as soon as the killed animal is field dressed and skinned. This also applies to injured animals even if they are not retrieved. If you would like to hunt additional days in the field then additional days can be booked prior to the hunt. If you are hunting with a party but your hunt has been completed and other party members have not finished their hunt then you can stay at camp or stay in the field with the hunters. If you decide to stay in the field then you can not have any weapon on you. Non-hunting guests can not have a weapon. Shooting game for other party members is not permitted. **If a second deer is wounded or killed then another deer hunt fee of \$4,750 will be charged to the hunter. If a second pig is wounded or killed then an additional \$750 fee will be charged to the hunter.**

Camping is permitted on the ranch at designated locations but you must leave no litter nor damage or alter the land. Camp fires are not permitted. Your camp must be broken down and cleaned up ready to go before the evening hunt on your last booked hunting day. Please do not bring pets with you to the ranch.

Arrival time will be determined prior to the hunt date. Departure time will be as soon as the hunted animal is field dressed and skinned or once the evening hunt has been completed of your last booked hunting day.

Client will be held responsible for any and all of Lockwood Hunting Services, guides, landowners, and its affiliates personal property they lose or damage.

Client authorizes LHS to use any videos and pictures of the client and the hunt for advertising and hunting videos for sale. Client waives any and all claim to profit that LHS may make from videos and pictures.

The client understands that LHS does not provide a hunting license and game tag. The client is responsible for obtaining a hunting license and game tag before the hunt is booked. A valid CA hunting license and game tag must be in the clients possession during the hunt at all times.

LHS reserves the right to cancel a hunt at anytime due to emergency closures, quota objectives, adverse weather, or other circumstances beyond LHS control. At that time an amendment of the contract for alternative dates will be made.

In accepting this agreement, I the client agree to assume and release Lockwood Hunting Services, guides, landowner and its affiliates from any and all liability for personal injuries, property damage or for loss of life or property resulting from, or in any way connected with the issuance of this agreement whether or not due in whole or in part to any act, omission, or negligence of Lockwood Hunting Services or any of its representatives. I the client agree to abide by all hunting regulations of the state of California. I the client agree to close all gates, leave no litter nor damage any property. I the client agree to comply with all fire restrictions and to only camp where permitted. I the client agree to know and follow the rules of gun safety, respect the rights of hunters, non-hunters and landowners and make every effort to retrieve and use all game. Should a claim arise, the client agrees the venue to resolve such issues shall be vested in the jurisdiction of the state of California, County of Mendocino. Should some legal action be taken prior to or at the conclusion of the trip and Lockwood Hunting Services prevails, the client agrees to pay all attorney fees and court costs incurred by Lockwood Hunting Services.
